The Council of the Municipality of New Lebanon, Ohio, met in regular session on Tuesday, July 3, 2018 at 7:30 p.m. with Mayor Arriola presiding. Present were Law Director Ronald D. Keener, Police Chief Rick Daulton, Zoning Compliance Officer David Lunsford, Clerk of Council Sandy Wright and several visitors. Municipal Manager/Fire Chief George Markus, Service Department Superintendent Scott Brock, and Chief Financial Officer Brenda Etter were absent.

PUBLIC COMMENTS OR QUESTIONS

My name is Terry Pellegrino, 2264 Broadmoor Drive, Kettering, Ohio 45419 stated I am here to promote and let everyone know or ask questions about the sunflower festival run 4 miler and 1 mile fun run we are having pre sunflower festival. We are starting out at 8:30 a.m. in the morning. We will have a 4 mile run and a 1 mile walk. You can also walk the four miles if you want so from 8:30 to 10:30 and we are working on the course to get that. I am here to answer any questions and talk about it. I have applications if anyone would like one to give to family and friends. I will mention it is not on the app that children five and under can participate free. So parents and grandparents can come out and walk with kids. The kids that pay for the 1 mile is also timed. You can get more information. You can play online and get more information at Key Sports. If you key in Key Sports Dayton you come up with 2018 races and scroll down to ours. You can sign up online too \$3.25 surcharge to sign up online. With an app it's free. With the paper app it is \$20.00 for the four miler, and \$10.00 for the one miler. You get a beautiful California blue T-Shirt and a goodie bag along with your time trace and awards for age group appropriate. So every 10 years essentially so overall male winner and overall female winner that will get a trophy and then metals for the first two finishers and age groups in 10 year increments.

Mr. Pellegrino stated Saturday, August 4, 2018. It is the same day of the Sunflower Festival.

Vice Mayor Madden asked are the routes going through the plats or are you going to try to keep it on Main Street?

Recreation & Community Development Specialists Cummins stated it is an extra mile. So it's 4 miles without Main Street because if you run down Rt 35 you would have to close off 35 for that whole time; Closing on Clayton and Bronwood. That was the original plan because the festival is here. We wanted it to start and end here.

Vice Mayor Madden stated we are going on fairly newly paved roads.

Police Chief Dauton stated there is no way I am going to shut down the roads to get in and out of New Lebanon in order to run your race. The other thing is trying to check with Jackson Township. The last time Jackson Township refused to shut down.

Mr. Pellegrino stated we will get with the timing people to get a better route and get back with you. I am anticipating 100 to 125 people. I will leave apps in the back for you to pick up.

We have lots of volunteers as well that come to help water and weed and take care of a space which is pretty cool. We are in the fourth week of Camp Connect. Two of our campers are here tonight. We typed this up quickly for you guys. This is an invitation for our celebration. It is not a very long program but the kids really enjoy it. They dress up and it's fun and we have food and refreshments. It is at the cafeteria at 7:00 pm on July 13th. We have another Friday Night Out coming up July 20th. It will be our third one and we will have lots of vendors with new life performance.
